In its December 16, 2010 Order Setting Deadline to Respond to the Complaint, this Court 1 ordered defendants to respond to plaintiffs' First Amended Complaint on or before January 27, 2011. 2 As set forth in the accompanying Declaration of Sherri Kaiser, defendants' counsel is unable to 3 comply with the January 27, 2011, deadline because of illness, and defendants therefore seek a brief 4 5 extension of time to file their response to plaintiffs' First Amended Complaint.
